Description

This product for use in: Hospitals, nursing homes, medical offices, dental offices, clinics, operating rooms, isolation wards, medical research facilities, restaurants, bars, cafeterias, institutional kitchens, fast food operations, food storage areas, supermarkets, convenience stores, retail establishments, wholesale establishments, dressing rooms, laundries, institutional facilities, laboratories, factories, business and office buildings, restrooms, hotels and motels and transportation terminals. Institutions, schools and colleges, churches, classrooms, athletic facilities, locker rooms, camp grounds, play grounds, recreational facilities, food processing plants, health clubs, spas, tanning spas, massage/facial salons and tattoo parlors.

This product is a one-step neutral disinfectant that is effective against a broad spectrum of bacteria, is virucidal* (including HIV-1, HIV-2, HBV and HCV) and inhibits the growth of mold and mildew and their odors when used as directed. This product, when used as directed, is formulated to disinfect the following hard nonporous inanimate environmental surfaces: floors, walls, metal surfaces, stainless steel surfaces, glazed porcelain, glazed ceramic tile, plastic surfaces, vanity tops, shower stalls, bathtubs, and cabinets.

Directions For Use

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

This product is not be used as a terminal sterilant/high-level disinfectant on any surface or instrument that (1) is introduced directly into the human body either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body.

KILLS HIV-1, HIV-2, HBV, and HCV ON PRE-CLEANED ENVIRONMENTAL SURFACES/OBJECTS PREVIOUSLY SOILED WITH BLOOD/BODY FLUIDS in health care settings (Hospitals, Nursing Homes) or other settings in which there is an expected likelihood of soiling of inanimate surfaces/objects with blood or body fluids, and in which the surfaces/objects likely to be soiled with blood or body fluids can be associated with the potential for transmission of Human Immunodeficiency Virus Type 1 or Type 2 (HIV-1 or HIV-2) (associated with AIDS), Hepatitis B Virus (HBV), and Hepatitis C Virus (HCV). CONTACT TIME: Allow surface to remain wet for 10 minutes.

DISPOSAL OF INFECTIOUS MATERIALS: Blood and other body fluids must be autoclaved and disposed of according to local regulations for infectious waste disposal.

First Aid

Call a poison control center or doctor for treatment advice. If swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow.

Do not induce voniting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice. NOTE TO PHYSICIAN

Probable mucosal damage may contraindicate the use of gastric lavage.
